Assumption of Risk and Covenant to Indemnify

I, the undersigned, hereby acknowledge and state that I know and am aware that all horses, whether privately boarded, leased or for riding lessons may vary in spirit, are subject to be startled, frightened, nervous reactions, and loss of control which may result in a horse throwing its rider, falling, slipping, jumping, kicking, and jostling riders, and other horses, with and without riders, or other like conduct, and persons on or about the stables and riding areas of the property of Grace Valley Stables & Training Center, LLC (16 Celestial Lane, Wallingford, CT), where some horses are privately boarded and or leased, some are used to teach horsemanship to persons with varying amounts of experience; and that horses, because of their weight, strength, weaknesses, and natural functions may create conditions in and on the stable, riding areas, and adjacent premises which are dangerous to persons thereon; I hereby assume the risk of injury and damage there-from as well as from all other conditions attendant thereupon as a condition to admission to the said course, said premises and the use of horses in connection therewith or apart there-from.

I, the undersigned, do hereby further agree to indemnify and hold its instructors, agents, and servants harmless from any and all claims on account of personal injuries and damages to property sustained or suffered by me, my personal representatives or derivative claimants arising out of my presence upon the Grace Valley Stables & Training Center, LLC facility resulting from my admission into the riding stable, riding areas, and from riding any horses furnished by me or to me in connection with said course or incidental thereto, or the use of said premises and horses apart from the said course.

From 91 N, take exit 14 (CT-150/Woodhouse Ave), turn right at the end of the ramp onto CT-150/Woodhouse Ave. Immediately merge left onto Powers Rd. Turn left onto Celestial Lane. The second driveway to the right is a private driveway. #18 is the second house on the right at the end of this driveway.

From 91 S, take exit 14 (East Center St.). At the end of the ramp, take a right onto E. Center St. and take an immediate left at the light onto South Airline Rd. At the next light, turn left onto CT-150/Woodhouse Ave. After the railroad tracks, merge left onto Powers Rd. Turn left onto Celestial Lane. The second driveway to the right is a private driveway. #18 is the second house on the right at the end of this driveway.
